- The total amount of Federal Title IV aid eligibility
- Tuition and Fee charges
- Room and Board charges, if applicable
- Class Attendance

After UNT personnel applies the federally mandated calculation, any unearned Federal Title IV funds (aid) will be returned to the programs from which the money was paid to you (or your parent).
