<u>DEADLINE</u>: Completed applications must be received by Student Financial Aid & Scholarships by 5:00 p.m., February 15, 2019 in order to be considered.

Texas Higher Education Coordinating Board Texas Education Code 54.331 Texas Administrative Code, Title 19, Part 1, Chapter 21, Subchapter U

1. Applicants must be a native born citizen of an eligible country of the Western (American) hemisphere other than the U.S. or Cuba.

2. Applicants must be residents of an eligible country, have that country as a home residence, and intend to return to that country to live immediately after finishing the educational program for which this award will be used.

3. Applicants must have resided in the Western (American) hemisphere for a period of at least five years.

4. Applicants must be scholastically qualified at the nominating institution to be considered by the nominating committee.

- New students must be <u>admitted</u> to a UNT degree program by the application deadline.
- Continuing UNT students must maintained satisfactory academic progress toward a degree according to UNT's published satisfactory progress rules. (Graduate students must maintain a 3.0 cumulative grade point average, and undergraduate students must maintain a 2.0 cumulative grade point average.)
- Students must be in good standing at UNT and must not owe a prior term balance.
- Students must not have excess hours as determined by the UNT Registrar's Office.

5. Applicants may not be members of the communist party.

6. Applicants must have a statement on file that indicates he/she is registered with the Selective Service System as required by federal law or is exempt from Selective Service registration under federal law.

7. The Texas Higher Education Coordinating Board awards 10 scholarships per eligible country each year in the entire State of Texas. There is no guarantee that a previous recipient will continue to receive this award.

8. Enrollment at an eligible institution is required to receive this scholarship as it exempts the student from the payment of tuition for a 12-month period. The student is responsible for paying all fees.
