SECTION B: AGREEMENT CRITERIA

University of North Texas (UNT) scholarships require recipients to fulfill certain criteria while they hold the scholarship. By accepting this UNT scholarship award, you confirm that you understand all the scholarship's criteria and understand that if you fail to fulfill these requirements, you forfeit all or a portion of the scholarship and waiver (if applicable).

- You must be active in a UNT degree program and must enroll and successfully complete the minimum credit hour requirement at UNT during each fall and spring term you hold this scholarship.
- Scholarships administered by UNT Student Financial Aid and Scholarships are funded through tuition revenue. As such, enrollment is required to receive this scholarship, and disbursements are applied to tuition and fee charges.
- You must maintain the minimum UNT cumulative grade point average at the conclusion of each term.
- You must complete the General Scholarship Application each year to ensure you are considered for scholarships for which you meet the established criteria. Online applications are available each fall term.
- Graduate faster, save money on tuition, and start earning money sooner by taking 15 credit hours per semester. Get all the details about available tuition options at sfs.unt.edu
- If you encounter any unusual circumstances that prevent you from meeting the criteria stated above, you may request a University Scholarship Appeal by emailing scholarships@unt.edu
- Competitive Scholarship Waivers for Non-Texas residents assessed non-resident tuition receiving UNT competitive scholarship(s) for at least \$1,000 will be assessed tuition costs at the in-state rate for each term of the award and applicable summer terms. Students receiving a competitive scholarship waiver of non-resident tuition must complete Selective Service Registration as required by federal law (www.sss.gov), according to applicable Texas Education Code 51.9095. Non-Texas residents residing outside of Texas and only enrolled in online courses should contact their major department for specifics regarding tuition charges.

SECTION C: SCHOLARSHIP ACCEPTANCE

I understand that a renewable scholarship offer is for an award that begins during the Spring 2022 term. Further, if I do not begin at UNT during the Spring 2022 term, I will only be considered for available scholarship opportunities based on my updated admitted status, and there is not guarantee of a future award.

By accepting this scholarship award, you agree to abide by the policies, rules, and regulations governing UNT. You authorize UNT to verify the information you have provided, and to utilize data from the Free Application for Federal Student Aid (FAFSA), as needed. You understand that recipient information may be provided to the donor(s) and/or UNT department(s) funding any scholarships received, released to high schools, and may be publicized in university materials. You authorize UNT to provide periodic performance updates to the selection committee(s) as needed, including members of organizations overseeing donor interests (i.e., foundations, trust administrators, etc.). Finally, you understand that the submission of false information is grounds for rejection and/or withdrawal of scholarship offer.

Please note that this scholarship may be adjusted if all scholarships (awarded by UNT or outside agencies) and other resources (federal, state, and institutional financial aid) available to you exceed the current cost of attendance at UNT, or your "need" for assistance as calculated by the Free Application for Federal Student Aid.
